(b) We, the Trustees, jointly and severally, indemnify InPoint Commercial and hold InPoint Commercial harmless from and against any liability relating to effecting any orders, transactions, instructions or directions given by any individuals listed in this agreement.

(c) We, the Trustees, agree to inform InPoint Commercial, in writing, of any amendment to the Trust, any change in the composition of the Trustees or any other event which could alter the certifications made above.

8. **All trustees must sign and date.**

Should only one person execute this agreement, it shall be representative that the signer is the sole Trustee. Where applicable, plural references in this certification shall be deemed singular. InPoint Commercial, in its sole discretion, may in certain instances require the written consent of any or all of the Trustees prior to acting upon the instructions of any Trustee. InPoint Commercial may require a copy of the trust in certain instances.
